1. Accurate input of consignee information for Canada bound shipments

1 State Code

No comma (,) and period (.) and 2 letters of alphabets can only be inputted. <u>Correct example:</u> BC <u>Wrong example:</u> B.C. (With comma)

B C (With extra space) (Blank, No entry))

AA (Invalid State Code)

No comma (,) and period (.) and 6-digits string consisting of alternating letters and numbers. <u>Correct example:</u> V2G 1H2 (ANA NAN [A=Alphabet, N=Number])

V6X0C7 (no space in between 3 digits is acceptable)

Wrong example: V3NOG2 (4th digit should be Number "Zero(0)" but Alphabet "O")

15055 (5-digits likewise U.S. ZIP Code)

00 (Dummy entry)

2. <u>Procedures for the U.S bound shipments where cargo data is directly filed to ACAS by customer</u>

Please kindly refer to below for specific procedure and attachment "(Request) Additional procedure to comply with ACAS program".

- 1 Please submit FHL (HAWB) data to ACAS in advance, and confirm "SF" is received before shipment is dropped off at JAL.
- 2 Please contact the local airport immediately in case "PER/PSN" is received from ACAS. %PER/PSN: [SN], [6H], [6J], [6I], [7H], [7J], [7I], [8H], [8J], [8I]
- ③ The following statement shall be entered on MAWB Handling Information column.

-Example-

(*Name of Agent*) has transmitted HAWB ACAS Data directly to U.S. authorities, and has received SF approval without any problems.

HAWB transmission to ACE Air Manifest by Agent Code : XXXXXXXXXX

3. Detailed commodity name required for all shipments

The commodity name "CONSOLIDATION" can only be used for MAWB for consolidated cargo. Commodity name for straight bill and HAWB should be provided in detail, please refer to below examples.
